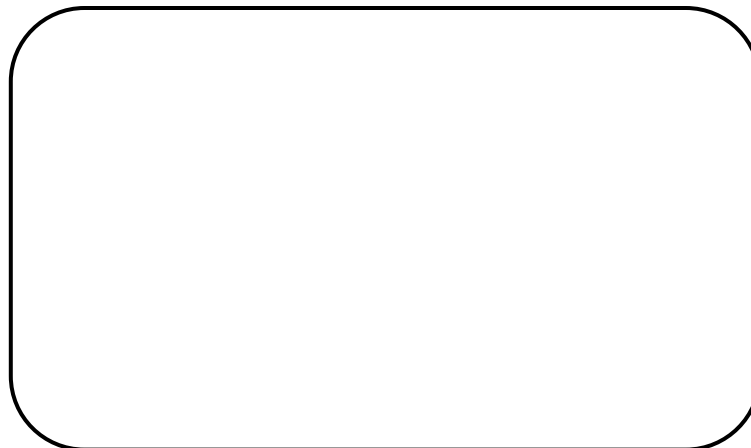

## VISA/MASTER CARD AGREEMENT

THIS AGREEMENT is entered as of \_\_\_\_\_, 20\_\_ by and between:

and VF JEANSWEAR LIMITED PARTNERSHIP (“Seller”).

WHEREAS Customer has requested to purchase product and services from Seller and Seller has agreed to supply such product and services subject to these “Terms and Conditions,” and whereas Customer and Seller mutually agree that such sales(s) will be accommodated via charges to and payments made by Customer’s credit card; now, therefore, Customer and Seller mutually agree that:

1. Purchases are typically made via telephone, via mail, via facsimile, or via other electronic means, any and all of which preclude Customer from physically presenting a valid credit card to Seller at the time of purchase,
2. Customer and Seller desire to protect each other from liability from unauthorized use of credit card number(s),
  - 2.1 To avoid the necessity of Customer and/or Seller having to verbally document and/or convey Customer’s credit card number and expiration date for each purchase transaction, Customer has supplied as a part of this Agreement a photocopy of each specific, valid credit card(s) issued in his personal or business name in order to provide Seller with a record of such credit card number and expiration date as a permanent part of Customer’s credit file information. Seller affirms that access to this credit card number will be limited only to authorized management personnel within its Credit Services Department and said credit card number will not be seen by other personnel involved in Order Entry, Customer Service, and/or Distribution. For security purposes as a means of validating a transaction, Seller may provide a portion of a credit card number to personnel directly involved in receiving orders.
  - 2.2 Customer has further provided to Seller a valid signature for each credit card provided.
  - 2.3 To avoid the necessity of Customer and/or Seller having to verbally document and/or convey Customer’s credit card number and expiration date for each purchase transaction, Customer has designated one specific card as the primary card to be billed for purchases. Customer may designate any other valid card at the time of purchase, provided the appropriate photocopies and signature outlined in Section 2.1 and 2.2 have been received by Seller.
3. Customer acknowledges that if an account with open terms is not granted, purchases and payments made via credit card are done as an alternative to open credit billing privileges.
